Additional information regarding sample selection. Households were contacted at random. The "next birthday" method was used to select which household member should complete the survey. The sample was weighted by inverse of family size. A weighting procedure was also used to improve sample representation: age, gender and occupation distribution were adjusted to the Ile de France population distribution.

Main objective To investigate knowledge, attitudes and beliefs towards smoking in a population sample from the Île-de-France region and to obtain information on smoking practices in that area.
