Inclusion criteria	Man or woman, over the age of 18 years, Having essential high blood pressure (HBP) treated for at least 1 year, Having a BMI < 25 kg/m <sup>2</sup> for patients of normal weight, Having a BMI ≥ 25 kg/m <sup>2</sup> for overweight or obese patients
