Inclusion criteria	"Male or female aged 18 years or older, - Hypertensive subject consulting, regardless of the reason. The investigator should include 4 patients as follows: - 2 hypertensive subjects treated for their hypertension 60 years or older - 1 hypertensive subject treated for their hypertension under the age of 60 years - 1 hypertensive subject not treated for their hypertension for at least 6 months. - Subject accepting to participate in the survey."
