**Main objective**

As with all of the registries in the FRANCIM network, the registry contributes in the development on a regular basis of incidence estimations of cancers for all of France. It contributes particularly to interpreting the trends in the incidence for cancer of the digestive system. In the same way, it participates in the work of the network pertaining to the survival of cancers and in all of the investigations concerning cancers of the digestive system provided for in the working program with the Institut de Veille Sanitaire. Locally, the registry responds to all invitations from the local health authorities (URCAM, DRASS, ARH) when planning the organization of care in cancerology.
