Data collection method	Batch summaries (RPS) for full-time and part-time treatment, and outpatient activity summaries (RAA) describing the establishment activity are submitted on a quarterly basis to the Technical Agency for Hospital Information (ATIH). These summaries include the following information: Patient age and sex ? home post code ? legal basis for care: voluntary or without consent; ? activity: day- or

night-time inpatient care; medical and psychological centre (CMP); outpatient treatment centre (CATTP), etc. ? diagnosis or grounds for principal and associated treatment (under ICD-10 coding). Specifically, for inpatient and outpatient care: ? length of stay (and session); ? admission and discharge method for stay (up to 2011); ? number of days in therapeutic isolation; ? Daily living activity dependence. Specifically for ambulatory services: ? Location of service; ? occupational category of stakeholders (MIPARESXY) ? type of service (EDGAR classification).
